

PPNO-2-037583 DEED OF DECLARATION OF PUBLIC CHARITABLE TRUST

This deed is executed on 128 Sept 98. by Mr. U.K. Modi S/O Late Shri G.M. Modi resident of 36 Amrita Shergill Marg, New Delhi, WHEREAS

The Managing Trustee is an industrialist.

The Managing Trustee is desirous of settling an amount of No.10,000 to create a charitable trust fund with the object of promoting education by establishing educational and vocational institutions, training students and providing them financial assistance by way of grants and scholarships and for other Charitable purposes as defined in section 2(15) of the Income Tax Act, 1961.

With this broad object the Managing Trustee has set apart the aforesaid sum of 8.10,000 as initial donation to create the trust, DAYA CHARITABLE TRUST (hereinafter called the Trust).



Mr. U.K. Modi and his wife Mrs. Kum Kum Modi shall be the original trustees. Mr. Abhishek Modi shall be the other Trustee and Master a Trustee on attaining majority. Mr. U.K. Modi shall be the Chairman & Managing Trustee and Mrs. Kum Kum "Modi shall be the Chair Person & Joint Managing Trustee (hereinafter called the Anaging Trustees). The Managing Trustees shall have the powers declaration. The Managing Trustees shall hold the office for shall jointly have all the powers of superintendence over the affairs of the trust and also to operate Bank accounts, borrow have the joint power to manage the funds of the Trust and to fix during their life time appoint their successor and on their Master Jayesh Modi on attaining the majority.

The Managing Trustees can nominate upto four additional trustees, who shall continue to remain nominee trustees of Managing Trustees. The Managing Trustees can jointly at any time remove or replace the nominee trustees at their discretion.

Registered Office of the Trust:

The registered office of the Trust shall be located in the state of Delhi.

The trustees shall have the power to form a subtrust to carry on the objectives of the trust and the registered office of the effectuate the objects of the Trust.

Trustees to hold funds upon trust:

The trustees shalf hold the sum of M.10,000 bequeathed for the purpose of this deed and all investments and accretions at any time and have powers for investing the same or any part thereof and all revenue arising therefrom upon trust to pay and to apply the same in accordance with the provisions and the directions hereinafter contained.

Objects of the Trust are to:

- 1. Promote education and research by setting up and running educational and vocational institutions or by taking over existing institutions.
- Make endowments and/or donations to Universities, Schools, Colleges and other educational institutions at present existing or which may hereafter come into existence in India for the purpose of encouraging or spreading general, medical or technical education including free or subsidised student's boarding houses.
- 3. Set up, establish or make endowments and/or donations to hospitals, asylums, maternity homes, sanatoriums, charitable gymnasiums, dispensaries, aushdhalayas, nature cure clinics and other institutions intended to provide medical relief and to promote physical health prevention and/or cure of human diseases.
- 4. Provide training in various educational and vocational fields.
- 5. Provide financial assistance by way of scholarships, fellowships, readerships and travel and other grants in respect of research and academic matters.
- 6. Set up or help by endowments or donations orphanages and/or poor houses for the benefit of orphans and poor persons or otherwise helping the poor and the needy persons in indigent circumstances.

- 7. Construct and maintain Reading Rooms, Community Halls, Dharamshalas, Public Rest Houses, Public Ghats and public wells and to feed the poor and maimed persons.
- 8. Contribute or donate to other similar institutions or trusts for advancement or promotion of any one or more of the objects of this trust.
- Accept donations, grants or like amounts in money or otherwise for the purpose of this trust.
- 10. Generally pursue such other objects of charity and public good as the trustees may think proper, "Charitable purposes" as per section 2(15) of the modifications and replacement therof in future.

Rules governing the management of the Trust:

This Trust is irrevocable. The trustees shall frame rules according to the objects of the Trust and as may be desired. The Trust shall be managed initially by the Managing Trustees jointly or any other trustee authorised indefinite period. No trustee or the Managing Trustees be rendered by them. The Managing Trustees to have absolute power to make decisions in case of any desired among the trustees.

Trust fund and its operations:

The trust fund shall be kept in accordance with the rules for investment of funds by charitable institutions as may be in force from time to time according to Income Tax Act, income of any other legislation governing taxation of income of charitable organization. The Managing Trustees operate Bank accounts on behalf of the Trust fund and to has an initial corpus of &.10,000 which shall be dealt in the manner provided in the deed. The object of the Trust shall be funded through the revenue earned from the corpus and accretions, however in no case initial corpus shall be liquidated or reduced.

Filling up of vacancies:

The power of appointing new trustees in place of existing trustees in case of their retirement, or resignation, or transfer, shall vest in the Managing Trustees jointly:

Investment:

The trustees shall have the power to acquire movable or immovable properties for the Trust and likewise the power to sell, lease or mortgage such properties.

Indemnity:

The trustees shall be kept indemnified for any loss or damage arising from any act or conduct done in bonafide exercise of powers under the trust.

Accounts:

All books of accounts shall be provided and kept by the Managing Trustees. Proper accounts in relation to the Trust shall be made out each year and duly audited by the professional accountants as the Trustees may appoint amongst themselves or employ from outside.

General power to make regulations:

The trustees shall have full power from time to time to make, alter, and rescind regulation for the conduct of their business including summoning of the meetings. All the acts and proceeding of the trust shall be taken and conducted in
